

Eligibility Requirements & Application Instructions

Financial Builders FCU is pleased to announce the gift of 1-\$1000.00 scholarship this year to be given to a high school senior student. One **Gary J. Follin Memorial Scholarship** will be awarded for each calendar year.

Applicants for such grants must be college bound senior students. Immediate family members of Financial Builders FCU employees are exempt from obtaining the scholarship. Selections and awards will be based on applicant needs and available funds. Applicants must present appropriate proof of need. Applicants are also selected on the basis of academic achievement and community involvement.

Complete applications must include the following:

- A completed application form including applicant's and a parent's or guardian's signature
- High School transcripts
- Proof of acceptance/attendance to a credited college or university
- Any additional information to aid the Scholarship Committee in the selection process.

The **Gary J. Follin Memorial Scholarship** committee will consist of the Financial Builders Federal Credit Union Board and one appointed Financial Builders Federal Credit Union management staff member. The committee will select the scholarship recipient and notify them promptly.
